Meeting was called to order at 3:00 pm by Mr. Chance.

A motion was made by Ms. Harant to approve the meeting minutes of March 16, 2017. Motion was seconded by Ms. Herman. Motion carried (5, 0).

In next item of business, a motion was made by Mr. Baker to approve the financial report. Motion was seconded by Ms. Harant. The report was summarized by Mr. Gulley. Mr. Gulley informed the Board that he received several notices from the Illinois Department of Employment Security regarding a lien in the amount of \$30,000.00 dating back to 2014 for unemployment insurance that was not paid. However, it was noted that the Care & Treatment Board no longer had employees as of June of 2013. Therefore, Mr. Chance stated that County Administration will be handling this; however, he asked Mr. Gulley to provide an update at the next meeting. Motion carried (5, 0).

Mr. Gulley informed the Board that he received an invoice for \$376.80 from Maloof for repair of a broken door hinge at the property on Knoxville. A motion was made by Ms. Herman to authorize payment of the invoice. Motion was seconded by Ms. Moberg. Motion carried (3, 2-Baker, Harant).

In the next item of business, agencies provided presentations on the programs for which they applied for funding.

In the next item of business, a motion was made by Mr. Baker to fund the seven grant proposals at the amount requested for the 2017-2018 grant period. Motion was seconded by Ms. Harant. Motion carried (5, 0).

The next meeting was scheduled for Wednesday, July 19, 2017 at 3:00 pm.

Mr. Runyon distributed a letter sent to legislators and the Journal Star from Illinois Partners for Human Service regarding the lack of a State of Illinois budget.

Mr. Guidi invited the Board members to attend an Illinois Council on Developmental Disabilities best practices forum in Bloomington on the morning of September 14, 2017. The Council has released a call for investment for half a million dollars for breaking down barriers for early intervention, education, and employment. Mr. Guidi stated that Camp Big Sky recently held its fishing tournament; \$21,000.00 was raised. He invited the Board members to visit the camp. Mr. Guidi introduced Karla Kane, new Camp Director at Camp Big Sky.

Ms. Gratton thanked the Board members for their support and hard work.

Being no further business, the meeting adjourned at 4:12 pm.
