



Peoria County Sustainability and Resource Conservation Department Food Scrap Composting Kits Giveaway – April 2021

RULES: This contest will run from Sunday, April 18, 2021 through Friday, May 7, 2021 5:00 p.m. CST. Three winners will be selected from all eligible entries on Tuesday, May 11, 2021. Winners will be notified by email and phone and will have 14 days (two weeks) to claim the prize. If a prize is not claimed within two weeks, an alternate winner will be chosen.

OFFICIAL GIVEAWAY RULES:

Odds of winning will depend on the total number of entries received. Do not enter this giveaway if you are not 18 years of age or older and a resident of Peoria County, Illinois. This giveaway is not associated with Facebook.
